What data do we collect?

How do we collect your data

You directly provide Mercon with the data we collect. We collect data and process data when you:

 Voluntarily apply for a vacancy or provide feedback on any of our massage boards or via email.

How will we use your data?

Mercon collects your data so that we can:

- Process your application.

How do we store your data?

Mercon securely stores your data in our datacenter. Only our HR department can see your data. Mercon will keep your personal data for the period of your application. Once this time period had expired, we will delete your data.

What are your data protection rights?

Mercon would like to make sure your are fully aware of all of your data protection rights. Every users is entitled to the following:

- **The right to access** You have the right to request Mercon for copies of you personal data. We may charge you a small fee for this service.
- **The right to rectification** You have the right to request that Mercon correct any information you believes is inaccurate. You also have the right to request Mercon to complete information you believe is incomplete.
- The right to erasure You have the right to request that Mercon erase your personal data, under certain conditions.
- **The right to restrict processing** You have the right to request that Mercon restrict the processing of your personal data, under certain conditions.
- The right to object to processing You have the right to object to Mercon processing
 of you personal data, under certain conditions.



- **The right to data portability** You have the right to request that Mercon transfer the data that we have collected to another organization, or directly to you, under certain conditions.
